Introduction

- 1. These terms and conditions ("**Terms**") form the basis of the opportunity to participate in the CMC Markets bonus offer ("**Offer**").
- 2. Taking part in this Offer constitutes acceptance of these Terms. CMC Markets Canada Inc. (Corporation No. 4303075) is the provider of this Offer ("CMC Markets").
- 3. Capitalised terms used but not defined herein have the meaning given to them in the CMC Markets' CFD Terms of Business ("ToBs").

Conditions of Eligibility

- 4. The Offer is available to customers who have satisfied the Eligibility Criteria (set out below) for the Offer ("Eligible Customer").
