Offer Period: 1 July 2025 to 31 August 2025

Introduction

1. These terms and conditions ("Terms") form the basis of the offer to participate in the "SG60 Promotion" Offer ("Offer").
2. Taking part in this Offer constitutes acceptance of these Terms.
3. CMC Markets Singapore Invest Pte. Ltd. (UEN 202217639M) ("CMC Invest"), is the provider of this Offer. CMC Invest is regulated by the Monetary Authority of Singapore.
4. CMC Invest reserves the right to vary or cancel any of these Terms at any time, subject to applicable laws.
5. Capitalised terms used but not defined herein have the meaning given to them in the CMC Invest General Terms and Conditions ("GTCs") and shall be construed accordingly.

Conditions of Eligibility
