

# CMC MARKETS NZ LIMITED CMC MARKETS X AUCKLAND BLUES 2021 SEASON GAME OF SKILL PROMOTION TERMS

#### Introduction

- 1. These terms and conditions ('Terms') form the basis of the CMC Markets X Auckland Blues 2021 Season competition ('Offer').
- 2. Taking part in this Offer constitutes acceptance of these Terms. CMC Markets NZ Limited is the provider of this Offer ('CMC Markets'). CMC Markets reserves the right to vary or cancel any of these Terms at any time, subject to applicable laws.
- 3. The Offer which an Eligible Entrant (defined below in paragraph 5) may enter is a game of skill, and chance plays no part in determining the winner. The winner of the Offer will be determined by a CMC Markets staff member acting as judge ('Judge'). There will be a maximum of 1 winner for the Offer.

#### Offer Period

4. The Offer is open on 30 April 2021 at 10:00am NZST and ends on 30 May 2021 at 11:55pm NZST ('Offer Period').

# Conditions of Eligibility

- 5. Entry is open to CMC Markets clients of New Zealand who satisfy the eligibility criteria in accordance with these Terms during the Offer Period ('Eligible Entrant'). Employees of CMC Markets or any other company within its group and their immediate family members are ineligible to enter the Offer.
- 6. To be eligible to be selected as a winner, an Eligible Entrant must, during the Offer Period provide a full response to the CMC Markets X Auckland Blues 2021 Season Questionnaire and submit the response to CMC Markets via the following channels:
