

Introduction

- 1. These terms and conditions ("Terms") form the basis of the offer to participate in the Red Friday Investment Portfolios Offer ("Offer").
- 2. Taking part in this Offer constitutes acceptance of these Terms. CMC Markets Stockbroking Limited (ABN 69 081 002 851, AFS Licence No. 246381) is the provider of this Offer ("CMC Markets").
- 3. CMC Markets reserves the right to vary or cancel any of these Terms at any time, subject to applicable laws.
- 4. Capitalised terms used but not defined herein have the meaning given to them in the CMC Markets Invest Terms and Conditions ("T&Cs") and CMC Markets Invest Financial Services Guide ("FSG").

Conditions of Eligibility

- The Offer is available to new customers who have satisfied the Eligibility Criteria for the Offer ("Eligible Customer").
