Introduction

1. These terms and conditions ("**Terms**") form the basis of the offer to participate in the "SingSaver Exclusive Promotion" ("**Offer**").
2. CMC Markets Singapore Pte. Ltd. (Company Registration No./UEN 200605050E) is the provider of this Offer ("**CMC Markets**"). Any individual who participates in this Offer accepts these Terms in full and agrees to be bound by all decisions of CMC Markets without limitation or qualification. CMC Markets reserves the right to vary or cancel any of these Terms at any time, subject to applicable laws. CMC Markets is regulated by the Monetary Authority of Singapore.
3. Capitalised terms used but not defined herein shall have the meaning given to them in the CMC Markets Next Generation Terms of Business and MetaTrader 4 Terms of Business (collectively, the "**TOBs**"), as the case may be, and references to the TOBs below shall be construed accordingly.

Conditions of Eligibility

4. The Offer is only available to individuals who have satisfied the Eligibility Criteria (as defined below) ("**Eligible Customer**").
5. The eligibility criteria ("**Eligibility Criteria**") are as follows:
 - a. the individual does not have, nor previously had, a live CFD account on the Next Generation Platform ("**Next Generation Account**") or a live CFD account on the MetaTrader Platform ("**MT4 Account**", and references to an "**Account**" shall, as the context requires, include either a Next Generation Account or a MT4 Account) at any time in the period of 12 months preceding the Offer Period;
 - b. the individual is a resident of Singapore and is aged 18 and above;
 - c. the individual is not an immediate family member of an employee of CMC Markets or any other company within CMC Markets' group as determined by CMC Markets in its sole and absolute discretion; and

Offer Period

6. The Offer shall begin on 1 September 2026 and shall expire on 31 December

The Offer Mechanics

For the purposes of this Offer:

“Eligible Trade” shall mean a CFD Margin Trade, Option CFD or Countdown that is opened and subsequently closed;

“SingSaver” shall mean SingSaver Pte. Ltd.;

“Turnover” shall mean the accumulated trading notional value; and

“Unique Referral Link” means the unique website link which is made available by SingSaver in respect of the Offer to Eligible Customers via email (or such other method of communication as determined by SingSaver).

9. The Tiers set out in Clause 8 above are not cumulative. The Eligible Customer will each be eligible for only one (1) Bonus based on the highest Tier that he/she satisfies. Legal
