

CMC CNY Upsized Welcome Bonus

CMC Markets Singapore Invest Pte. Ltd.

Introduction

1. These terms and conditions ("**Terms**") form the basis of the offer to participate in the "CMC CNY Upsized Welcome Bonus" (the "**Offer**").
2. CMC Markets Singapore Invest Pte. Ltd. (UEN No: 202217639M) ("**CMC Invest**") is the provider of this Offer. Any individual who participates in the Offer accepts these Terms in full and agrees to be bound by all decisions of CMC Invest without limitation or qualification. CMC Invest is regulated by the Monetary Authority of Singapore.
3. CMC Invest reserves the right to vary or cancel any of these Terms at any time, subject to applicable laws.
4. Capitalised terms used but not defined herein shall have the meaning given to them in the CMC Invest General Terms and Conditions ("**GTCs**") and shall be construed accordingly.

Conditions of Eligibility

5. The Offer is only available to individuals who have satisfied the following eligibility criteria ("**Eligibility Criteria**", and an individual who has satisfied the Eligibility Criteria shall be an "**Eligible Customer**"):
 - (a) he/she does not have, nor previously had, an account (including any joint account) on the CMC Invest platform ("**Account**");

For the purpose of this Offer:

“**Alibaba Share**” shall mean an American depository share in Alibaba Group Holding Limited, which is listed on the New York Stock Exchange under the ticker symbol ‘BABA’;

“**Buy Trade**” shall mean an order placed and executed through an Account for the purchase of any Investment Product and shall not include any Transaction executed solely for the purpose of selling or closing any position in an existing Investment Product;

“**Tencent Share**” shall mean an ordinary share in Tencent Holdings Limited, which is listed on the Hong Kong Stock Exchange under the stock code ‘700’; and

“**Unique Promotional Code**” shall mean the promotional code which is made available by CMC Invest in respect of the Offer.
