

MoneySmart Exclusive Welcome Bonus

CMC Markets Singapore Ltd.

Offer Period: 17 August 2026 to 30 September 2026

Introduction

1. These terms and conditions ("**Terms**") form the basis of the offer to participate in the "MoneySmart Exclusive Welcome Bonus" Offer (the "**Offer**").
2. CMC Markets Singapore Pte. Ltd. (UEN No: 200605050E) ("**CMC**"), which operates the CMC Invest Platform, is the provider of this Offer. Any individual who participates in the Offer accepts these Terms in full and agrees to be bound by all decisions of CMC without limitation or qualification. CMC is regulated by the Monetary Authority of Singapore.
3. CMC reserves the right to vary or cancel any of these Terms at any time, subject to applicable laws.
4. Capitalised terms used but not defined herein shall have the meaning given to them in the CMC Invest Platform General Terms and Conditions ("**GTCs**") and shall be construed accordingly.

Conditions of Eligibility

5. The Offer is only available to individuals who have satisfied the following eligibility criteria ("**Eligibility Criteria**") and an individual who has satisfied the Eligibility Criteria shall be an "**Eligible Customer**":
 - (a) he/she does not have, nor previously had, an account (including any joint account) on the CMC Invest Platform ("**Account**");
 - (b) he/she is a resident of Singapore and is aged 18 or above;
 - (c) he/she is not an immediate family member of an employee of CMC or any other company within CMC's group as determined by CMC in its sole and absolute discretion; and
 - (d) he/she must be eligible to open a live and unrestricted Account as determined by CMC in its sole and absolute discretion.

Offer Period

6. The Offer shall begin on 17 August 2026 and shall expire on 30 September 2026, unless CMC determines otherwise at its sole and absolute discretion ("**Offer Period**").

The Offer Mechanics

7. Eligible Customers who satisfy any of the criteria as stated in Clause 8 below (“**Criteria**”) may receive the corresponding bonus (“**Bonus**”). Unless otherwise determined by CMC, CMC shall award all Bonuses into the Account of a successful Eligible Customer on or around 10 business days after 30 September 2026.
8. The Criteria and its corresponding Bonus are as follow:

“**MoneySmart**” shall mean the online personal finance comparison platform operated by the MoneySmart Group.

“Grab Share” shall mean an ordinary share in Grab Holdings Limited, which is listed on the NASDAQ under the ticker symbol ‘GRAB’;

“Mattel Share” shall mean an ordinary share in Mattel, Inc., which is listed on the NASDAQ under the ticker symbol ‘MAT’; and

“Unique Referral Link” means the unique website link which is made available by MoneySmart in respect of the Offer to Eligible Customers via email (or such other method of communication as determined by MoneySmart).

9. All Bonuses are strictly limited to one (1) Bonus per Winner. Each Eligible Customer will only be entitled to one of the Bonuses above, selected based on the highest criteria that he/she qualifies for. Eligible Customers will not be entitled to claim both the Bonus from the Basic Criteria and the Bonus from the Additional Criteria.
10. CMC may at any time and without prior notice in its sole and absolute discretion and without assigning any reason, substitute the Bonus with any other item of a similar or greater value.
11. All Bonuses will not be awarded in respect of any Buy Trades that are subsequently voided, reversed or cancelled by CMC in accordance with our GTCs. If the Bonus has already been paid in respect of any Buy Trades that are subsequently voided, reversed or cancelled by CMC, CMC will reclaim the Bonus (or its cash equivalent) awarded in respect of such Buy Trades from the relevant Account.
12. The Cash Bonus does not represent a commitment to make further payments in the future.

Legal

16. CMC reserves the right to forfeit, withhold and/or withdraw any Bonus (whether in part or in whole) or where the Bonus has been awarded, reclaim and/or
