Welcome Bonus

CMC Markets Singapore Invest Pte. Ltd.

Offer Period: From 10 April 2025 until further notice

Introduction

- 1. These terms and conditions ("Terms") form the basis of the offer to participate in the "Welcome Bonus" Offer ("Offer").
- 2. Taking part in this Offer constitutes acceptance of these Terms.
- 3. CMC Markets Singapore Invest Pte. Ltd. (UEN 202217639M) ("CMC Invest"), is the provider of this Offer. CMC Invest is regulated by the Monetary Authority of Singapore.
- 4. CMC Invest reserves the right to vary or cancel any of these Terms at any time, subject to applicable laws.
- 5. Capitalised terms used but not defined herein have the meaning given to them in the CMC Invest General Terms and Conditions ("GTCs") and shall be construed accordingly.

Conditions of Eligibility
