If you trade US shares, you are required to complete a withholding tax form. This is to determine your status for US tax purposes. You can now electronically lodge the applicable withholding tax form through our platform.

This concise guide is to help you easily use the US Tax Form e-lodgement tool within our platform.



How to access the US Tax Form e-lodgement Tool

Step 1: Login to your stockbroking account.



Step 2: Once logged in, hover over the Support menu at the top right corner of the platform and click on the 'US Tax Form' option.



This will open the US Tax Form Information page. Here you will be able to view the details of each account holder and the expiry dates for the relevant US Tax Forms.

Step 3: Select the Account from the drop down and click on the Update/Lodge Form button to launch the US Tax Form e-lodgement Tool. This will open in a new tab.

You can now electronically lodge the applicable US tax form through our third party supplier (IHS Markit). Please take care to ensure you are choosing the right section before filling out the form. Refer to the user guide for assistance.

The form should take 15 - 20 minutes to complete, and you will need the below information to complete the form:

- Permanent residential address this must match the address stored on your account information (if this does not match please update your address prior to submitting your US tax form).
- Tax File Number (TFN) for Australian residents.
- · Foreign Tax Identification number (TIN) (if applicable).
- Social security number or Employer identification number if you are a US citizen lodging a W-9 form.
- If the form relates to a non-individual entity, you will need your FATCA information to hand.

Company, Trust, or SMSF accounts are required to lodge one W-8BEN-E (Entities) or a W-8IMY for the account. In certain situations, entities completing a form W-8IMY may be required to complete separate forms for their beneficiaries. Accounts with multiple trustees/directors should make a resolution authorising a specific trustee or director to make the relevant certification on the form.

Joint accounts require each account holder to lodge individual W-8BEN or W9 (Individuals) forms. Please note, you can only submit one form per account where you are the account holder.

Once you submit the form, it may take up to 24 hours to be finalised. After this time, if you do not think your form submitted correctly, please contact us via Live Chat.

Data collected on the forms is stored securely and used by us to meet IRS reporting requirements. We don't provide this data to any third parties other than the IRS.

- For individual, joint and minor accounts, the name of the account holder logged in is used. This is since each account holder is the beneficial owner and is required to complete W-8BEN (individual) forms.
- Please note for joint accounts, all account holders must complete W-8BEN forms in order to claim the reduced withholding tax (WHT) rate.
- For other account types the account name will be used for the Legal Name.
