Introduction

- 1. These terms and conditions (**Terms**) form the basis of the offer to participate in the CMC Markets "Refer a Friend Bonus" Offer (**Offer**).
- 2. Taking part in this Offer constitutes acceptance of these Terms.
- 3. CMC Markets NZ Limited is the provider of this Offer (**CMC Markets**). CMC Markets is regulated by the Financial Markets Authority of New Zealand.
- 4. CMC Markets reserves the right to vary or cancel any of these Terms at any time, subject to applicable laws.
- Capitalised terms used but not defined in this document have the meaning given to them in the CMC Markets NZ Limited Product Disclosure Statement (PDS), the General Terms and Conditions of Trading, the Next Generation Terms and Conditions of Trading, the Next Generation Platform Sales Trader Terms and Conditions of Trading or the MT4 Platform Terms and Conditions of Trading (as applicable) (the CMC Markets Documents).

Offer Period

6. The Offer is open from 9 September 2024 and will remain open until such time as CMC Markets determines, in its sole discretion, that the Offer is no longer available (**Offer Period**).

Eligibility Criteria

- 7. The Offer is only available during the Offer Period to individuals that satisfy each of the criteria set out in clauses 8 (**Referrer**) or 9 (**Invitee**) below.
- 8. A Referrer must:
 - (a) have an Account and remain eligible to maintain that Account until the Bonus Criteria (defined in clause 10 below) are satisfied;
 - (b) be a resident of New Zealand;

- 18. All persons taking part in the Offer, to the maximum extent permitted by law, release from, and indemnify CMC Markets against, all liability, cost, loss or expense arising out of or in connection with the Offer including (but not limited to) personal injury and damage to property and whether direct or consequential, foreseeable, due to any negligent act or omission or otherwise.
