Introduce a Friend Bonus

Terms and conditions

- 1. Capitalised terms used but not defined herein have the meaning given to them in the CMC Markets UK plc Terms of Business or the CMC Spreadbet plc Financial Betting Terms of Business (as applicable to you), (the "Terms"), and references to the Terms below shall be construed accordingly.
- 2. Except as may be varied below in relation to the 'introduce a friend' bonus, the Terms apply to this offer. References below to 'CMC Markets' are collectively to CMC Markets UK plc and CMC Spreadbet plc.
- 3. Subject to the terms set out below, the 'introduce a friend' bonus enables live CFD or spread betting Account holders to earn a referral bonus by introducing friends who go on to successfully open a Next Generation Account with CMC Markets. For each successful introduction, both the Account holder and the friend will each receive a £200 credit on their Account (both payments being together the "Bonus"). You can only refer each friend once, and the Bonus is only payable on the first Account opened by each friend. In the case of new Joint Accounts, only one Bonus will be payable to the Joint Account and you.
- 4. The Bonus should not form the basis of any decisions made in relation to potential CFD Margin Trades, Bets, Countdowns, Binaries or Account activity.
- 5. In order to qualify for the Bonus, all of the following conditions must be met:
 - a) you must hold a live CFD or spread betting Account;
 - b) your friend must not be a current Next Generation Account holder;
 - you must have an existing personal (not business) relationship with the person you
 wish to refer and they must otherwise be eligible to open a live CFD or spread
 betting Account (as applicable) with CMC Markets;
 - d) by forwarding the email received from CMC Markets to your friend you confirm that your friend consents to receive such email;
 - e) your friend must apply for an Account via the unique link contained in the email. Applications not made through the link in the email will not be eligible for the Bonus (both on your friend's Account and yours);
 - f) your friend must deposit a minimum of £1000 within the first 60 days following confirmation of opening a live CFD or spread betting Account (as applicable); and
 - g) your friend must trade the equivalent of £100 in applicable trading costs (such as Spread, Commission, Holding Costs and/or GSLO Premium, but not market data

fees) within the first 60 days following confirmation of opening a live CFD or spread betting Account (as applicable).

- 6. The relevant portion of the Bonus will be credited to each Account automatically after all the qualifying conditions have been met. CMC Markets reserves the right to decline to open a CFD or spread betting Account (as applicable) at its sole discretion and without giving any reason for doing so. CMC Markets will not be liable for any loss caused to you and/or your friend by any delay in payment of the Bonus.
- 7. You will not be permitted to have a power of attorney or any other authority to trade on any friend's Account(s) opened and in receipt of the Bonus, at any time.
- 8. This offer must only be used for personal and non-commercial purposes. The personalised links should not be published or distributed publicly. CMC Markets reserves the right to refuse to pay the Bonus to you and your friend(s) where it suspects (in its sole discretion) non-compliance with this term.
- 9. CMC Markets will not be liable to you or your friend in relation to the Bonus (including for any losses arising as a result of use of the Bonus) and the provisions of clause 7.2 of the Terms shall apply to the Bonus as if set out here in full.
- 10. In addition to any other rights and remedies available to CMC Markets, in the case of any breach or suspected breach of the Terms in relation to an Account, CMC Markets is entitled to deem such Account ineligible for the Bonus, and/or reclaim any Bonus previously paid pursuant to this promotion. This promotion cannot be combined or used in conjunction with any other offer, rebate or promotion offered by CMC Markets.
- 11. This offer is subject to English law and the exclusive jurisdiction of the English courts, and may be withdrawn or amended at any time, without prior notice at the sole discretion of CMC Markets. CMC Markets' employees and members of their households are not eligible to participate.
- 12. CMC Markets reserves the right to amend, withdraw or restrict this offer at any time without notice.
